 - ハ 午前0時から午前6時までの間に水先を開始する予定の船舶について、前日の午後11時以后において取消のあった時。
- (2) 前項イ及びロの場合、当水先会事務所を出発した時刻が午後5時から翌日の午前8時までの間にある時の取消料は、前項の取消料の100分の150に相当する額とする。

2 待機料

水先人が乗船後又は水先開始地点において待機後、水先開始予定時刻から起算して当該船舶の船長の責に帰すべき事由により1時間を超える時間を待ったとき、その超えた時間1時間（1時間に満たないものは1時間とする。）ごとに10,800円を申し受ける。

※ 平成26年4月1日、消費税等の改正に伴い水先法施行規則の改正及び水先約款の変更により「水先料の額」、「取消料」、「待機料」、「区域運行経費」及び「その他の補償」については、次の各号に掲げる船舶の水先をする場合には100分の108に相当する額とする。

- ・ 日本国籍の内航船舶
- ・ 日本籍の練習船、自衛艦、調査船、作業船等のように、貨物又は旅客の運送により運賃を得る船舶以外の船舶（外国航路に従事するものであっても課税対象となる）

* Special Charges

1. Cancellation fees

- (1) When any of the following are applicable, a cancellation fee of ¥21,600 is charged.
- When pilotage is cancelled after a pilot has left the pilot station as a result of a request for pilotage service
 - When the master of a vessel cancels pilotage without proper reasons after a pilot has set out to undertake pilotage in the said vessel as a result of a request for pilotage service
 - When a vessel in which pilotage is scheduled to commence between 12:00 p.m. (midnight) and 6:00 a.m. cancels the pilotage after 11:00 p.m. on the previous day.
- (2) If applicable to a. and b. above, and when the pilot leaves the pilot station between 5:00 p.m. and 8:00 a.m. on the following day, a cancellation fee equivalent to 150/100 of the aforementioned cancellation fee is charged.

2. Standby charges

When a pilot stands by for more than one hour after boarding the vessel or waiting at the point where pilotage is intended to commence, counting from the scheduled time for starting piloting, because of reasons for which the master of the vessel to be piloted is responsible, a fee of ¥10,800 is charged for each hour exceeding the scheduled time for starting piloting (when standby time is less than one hour, it is regarded as one hour).

* Because of the revision of the Pilotage Law Enforcement Regulation and changes in the Pilotage Clause in accordance with the revision of the consumption tax and other revisions on April 1, 2014, the amount equivalent to 108/100 of "pilotage charges," "cancellation fees," "standby charges," "expenses for escorts in the port" and "other compensations" are charged for piloting the following vessels:

- Domestic vessels of Japanese registry
- Vessels of Japanese registry, such as training ships, Maritime Self-Defense Force vessels, research ships, work ships, and other vessels which do not charge fares by transporting cargo or passengers (Tax is charged to ocean liners as well.)
